

SUMMER POOL SHUTTLE

Free bus rides are offered by Edgerton Parks and Recreation so our community can enjoy the Wellsville City Pool.

1:15-1:30 p.m.	Rider pick up at Edgerton Library
1:30 p.m.	Depart from Edgerton Library
1:45 p.m.	Arrive at Wellsville City Pool
3:45 p.m.	Rider pick up at Wellsville City Pool (Bus departs from library at 3:45)
4:00 p.m.	Return to Edgerton Library

Wellsville City Pool: 6th, Wellsville, KS 66092

Age:

- Any rider under the age of 8 must be accompanied by a supervising adult.
- Parents of unsupervised riders must provide emergency contact information while registering.

Fees / Pool Passes:

Riders are required to have one of the following before boarding the bus:

1. A Season Pass for the Wellsville City Pool,
2. A Daily Pass for the Wellsville City Pool, or
3. \$2.50 in cash to buy a Daily Pass for the Wellsville City Pool.

Registration:

Each rider must register for the Summer Pool Shuttle by completing the registration form and returning it to Edgerton City Hall or to the Parks & Recreation staff member before a field trip.

Signing in and wristbands:

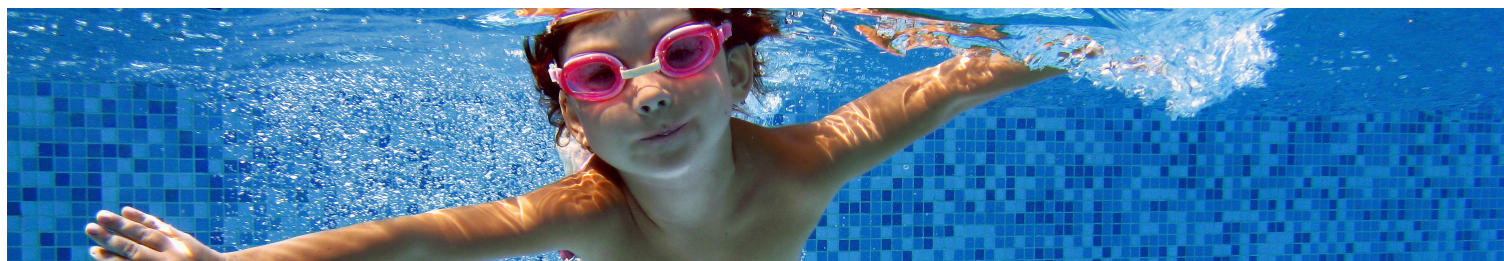
To help the City of Edgerton staff member identify participants, riders are required to:

1. Sign in before boarding the bus both in Edgerton and Wellsville, and
2. Wear a wristband that identifies them as a rider.

Staffing:

One City of Edgerton staff member will be present on the bus and at the pool for the sole purpose of communicating and enforcing program guidelines. This staff member is not responsible for any child supervisory roles.

Inclement Weather: The City of Edgerton staff member, in conjunction with the Wellsville City Pool staff and the bus driver, will determine the best course of action in the event of inclement weather. This could include field trip cancellation, early return to the Edgerton library or emergency shelter at the Wellsville Pool or on the bus. The driver will be the final authority in determining when it is safe to drive and will take all measures necessary to keep riders and staff safe.

RESPONSIBILITY OF RIDERS: While the City of Edgerton staff member will be tracking riders, he/she will not be responsible for making sure riders make the bus on time. If an unaccompanied child is not capable of keeping time or responsible enough to make the bus on time, the parent should not allow them to ride.

Riders are responsible for conducting themselves appropriately on the bus and at the swimming facility. Any person that is suspended or prohibited from a facility while on the trip shall be ineligible for any future trips for the remainder of the summer or from riding the bus to the pool. Riders must be in dry clothes or have a towel to keep the bus from being made slippery or wet. No outside food or drinks will be allowed on the bus. If the staff member has to go find a participant at the time of scheduled departure from the Wellsville Pool, making the bus late, the participant will be suspended for one week or the participant will not be allowed to participate in swim trips for the remainder of the season. This determination will be made by the City of Edgerton staff member.

UNRULY OR UNSAFE RIDERS: Any participant, regardless of age, that is unruly or unsafe during the trip, or creates an unruly or unsafe condition for the City of Edgerton staff member, the bus driver, or any other participant will be prohibited from riding the bus for the remainder of the season. If the City of Edgerton staff member or the bus driver determines it would be a threat to their safety or to the safety of others for an adult person to return to Edgerton, the driver or staff may insist that the adult rider (and all children under their care) exit the bus at the driver's discretion. The adult or responsible person will then be responsible for making arrangements to return to Edgerton. Should an unaccompanied child leave the swimming facility or immediate parking area or leave the facility, the City of Edgerton staff member will contact the Wellsville Police Department and Johnson County Sheriff's Department who will work with local law enforcement to treat the child as a runaway.

LIABILITY RELEASE: I, as a participant or legal guardian representing a minor participant agree to release the City of Edgerton, its officers, employees and volunteers, from any and all liability for accidents, injuries, loss of and/or damage to my/our person or property that may arise out of my/our participation in/and our presence at the registered activity.

I HAVE READ AND UNDERSTAND ALL SECTIONS OF THE REGISTRATION FORM AND THE PROGRAM GUIDELINES, INCLUDING THE RESPONSIBILITY OF RIDERS, UNRULY OR UNSAFE RIDERS, AND LIABILITY RELEASE; REGISTRATION IS INVALID WITHOUT SIGNATURE.
